

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF ALL RISKS, AND CONSENT TO USE OF LIKENESS

By reading this document and signing below, I agree that:

1. I have voluntarily decided to participate in activities and events at, and use the facilities of, "The Funbox" Skate Park, which is owned and operated by Jameson Entertainment Corporation.
2. I am voluntarily participating with the knowledge of the numerous risks and dangers involved, including but not limited to: physical exertion for which I may not be prepared; breakdown of equipment, whether rented or owned; accident or illness; the risk of negligence by myself or others, including Jameson Entertainment Corporation; and the potential for serious injury, including permanent paralysis or death.
3. I will follow all written and verbal rules of safety presented to me by Jameson Entertainment Corporation.
4. The enjoyment and excitement of skating and biking is derived in part from the inherent risks associated with an activity that is beyond the generally accepted margins of safety, and that these inherent risks contribute to such enjoyment and excitement, and are one of the significant reasons for my participation.
5. I am responsible for my own welfare and accept any and all risks unanticipated or anticipated events, illness, injury, emotional or physical trauma or death.
6. One of the conditions to entering "The Funbox" and using its facilities is my execution of this Waiver; therefore, as lawful consideration for being permitted to enter "The Funbox" and use its facilities, I hereby RELEASE AND DISCHARGE FOREVER JAMESON ENTERTAINMENT CORPORATION, ITS SHAREHOLDERS, DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND THE OWNERS AND LESSORS OF PREMISES USED TO CONDUCT A JAMESON ENTERTAINMENT CORPORATION RELATED EVENT ("RELEASEES"), FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM MY USE OF "The Funbox" OR PARTICIPATION IN ACTIVITIES OR EVENTS AT "The Fun Box."
7. This release shall be legally binding upon me personally, all members of my family, and all minors accompanying me, my heirs, successors, assigns and legal representatives, it being my intention to fully assume all of the risks associated with my use of Jameson Entertainment Corporation Skate Park facilities and to release us from any all liabilities associated with my use of Jameson Entertainment Corporation Facilities to maximum extent permitted by law.
8. I understand that Jameson Entertainment Corporation reserves the right to refuse admittance to any person who refuses to sign this waiver or who it judges to be incapable of meeting the rigors and requirements of participation in the activities.
9. Jameson Entertainment Corporation, its agents, successors and/or assigns, reserve the right to take photographic, film, audio, or digital records of me using Jameson Entertainment Corporation Skate Park, facilities, or participating in events or activities sponsored by Jameson Entertainment Corporation ("Jameson Entertainment Corporation Media"), and I further agree that Jameson Entertainment Corporation may use any such Jameson Entertainment Corporation media for promotional and/or commercial purposes, as well as approved such use by third parties whom Jameson Entertainment Corporation may engage in joint marketing, without any remuneration to me. I hereby assign Jameson Entertainment Corporation all right, title and interest I may have in or to Jameson Entertainment Corporation Media and grant Jameson Entertainment Corporation a royalty-free, exclusive, perpetual and irrevocable license to the Jameson Entertainment Corporation Media.
10. I agree that any dispute or claim concerning this Agreement shall be resolved exclusively by binding arbitration according to then-existing rules of the American Arbitration Association and Hyannis, Massachusetts. Massachusetts law shall govern this Agreement, excluding any application or in consideration of any conflict of law's provisions.
11. Jameson Entertainment Corporation cannot forcibly require minors to remain in the building and is not responsible for any participant who leaves the facility.
